

RENTAL PROTECTION PLAN FOR PASSENGER VEHICLES

The Rental Protection Plan (RPP) is a simple, affordable and smart way to protect yourself from the unforeseen. United Rentals offers a comprehensive program to provide you with added protection for the most common problems:

- Accidental damage to United Rentals Passenger Vehicles
- Theft of United Rentals Passenger Vehicles

EXAMPLE: CUSTOMER DAMAGES A PASSENGER VAN WORTH \$50,000 WHILST DRIVING

	Without RPP	With RPP
Rental of Passenger Van	\$400	\$400
Cost of RPP	\$0	\$60
Initial Out-of-Pocket	\$400	\$460
Cost of repairs	\$5,000	\$5,000
Deductible	\$0	\$500*
RPP Benefit	\$0	\$4,500
Total Cost to Customer	\$5,400	\$960

* Plus, applicable state and local taxes.

The Rential Protection Plan does not apply in situations involving damage that may be a result of intentional abuse or damage to tires and tubes caused by blow out, bruises, cuts, punctures or other causes inherent in the use of the equipment.

Customer will remain responsible for all costs and fees after the first \$7,500.00 per rental period, for losses arising from theft of or direct physical damage to the Passenger Vehicle. United waives its right to collect \$500.00 from Customer if the losses arising from theft of or direct physical damage to the Passenger Vehicle exceed \$7,500.00 per rental period.

RPP covers...

Damage to or theft of United Rentals Equipment	Accidental damage, as long as the damage does not result from intentional abuse of the equipment.
Damage to or theft of United Rentals Passenger Vehicles	Damage to United Rentals Passenger Vehicles up to \$7,500.00 provided the customer or permissive user of a customer does not use the Passenger Vehicle in violation of any terms of the Rental Agreement or of any law.

RPP does not cover...

Damage to Tires	Damage to tires and tubes caused by blow out, bruises, cuts, punctures or other
	causes inherent in the use of the equipment.
Damage to Equipment or Passenger Vehicles Resulting from Abuse	Damage to equipment or Passenger Vehicles resulting from intentional abuse.

^{**}Customer is responsible for the care and safekeeping of the rental equipment from the time of delivery until retrieval by the Company. Customer agrees that it will use its best efforts to protect the equipment from loss, theft, or damage at all times during the rental period, and until the equipment is retrieved and in the Company's possession.
